2.	Can I Enter?	Entry is open to New Zealand residents aged 6-15 years old. <b>(Eligible Entrant).</b>			
3.	Parent or Guardian Approval	You must have your parent or guardian's approval to enter. Your parent or guardian must have read and consented to these Terms and Conditions and may need to enter into an agreement to show their consent to you entering the Event, Promotion or accepting any Prize. Parents, if you do not agree to these Terms and Conditions, you agree you will not register your child to enter any Event.			
4.	When can I enter the Event?	Entry opens on 21 August 2023 and ends on 7 April 2024.			
5.	How do I enter?
